SOCIETIES REGISTRATION ACT, XXI OF 1860 AMENDED RULES & REGULATIONS

PRILIMINARY: The name of the Societies Registration Act, 1860 shall apply to this society.

INTERPRETSTION 2 In these Articles:-

- The expression "Society" and the word "Committee" wherever used means the "Mata Gujri 0) Academy Village Amipur, P.O.Bhopar Saidan, Distt.Gurdaspur
- The "Chairman", the Vice Chairman ", the Secretary", and the "Finance Secretary" means the Chairman, The Vice Chairman, the Secretary or the Finance Secretary of the Academy, as Well. b)
- The "Member" means the member of the Managing Committee. c)
- The office Registered office of the Society for the time being.

MAXIMUM AND MINIMUM 2

The Maximum numbers of the managing Committee shall be twenty one While the Minimum number of the members shall be seven respectively.

MEMBERSHIP AND ANNUAL SUBSCRIPTION

Membership of the society in open to may person over eighteen years of age and who shall have interest in the development of the Education Institutions/ Academy.

- c) He is dedicated to the cause of Education.

ADMISSION OF NEW MEMBER -5.

In case of vacancy in the Managing Committee, it shall be Filled within there months. A Person over 18 years of age, bearing good moral character, dedicated to the cause of education and development of the Society shall become the member of the Managing Committee; if 50% of Member of the Managing Committee recommends his/ her name and is approved by the Chairman. The admission fee and annual subscription shall be decided by the governing body of the Society from time to time.

DISQUALIFICATION OF MEMBER

8. POWERS OF THE OFFICE BEARERS

1. The Chairman

He shall preside over, control and take decision in the meeting. He is authorized to sign all the correspondence on behalf of the society with any governments or other departments, banks etc.

2. The Vice-Chairman

He shall perform the function of the Chairman in the absence of Chairman or act on his behalf.

3. The Secretary

He/She shall keep the record of the proceeding of the meeting of the Managing Committee on the advice of the Chairman. He /She Shall perform all other such Dutles as assigned to him/ her by the Chairman.

4. The Finance Secretary

He / She shall keep the records of the proceeding of the meeting of the Managing Committee. He/ She shall call the meeting of the Managing Committee on the Advice of the Chairman He/ She shall look after the accounts of the Society and Properly maintain it and present statement of accounts in the annual meeting of the society. He will collect all funds of the committee from member, from Govt. from students and from outsiders. He/ She shall perform all other such duties as assigned to him/ her by the Chairman.

Powers of the Managing Committee

- To control the budget, consider and pass the Balance Sheets and audit reports of the Schools/ Academy.
- To consider the annual log book reports of the working of the Schools/ Academy as submitted by the Vice-Chairman.
- To control movable and immovable properly of the School / Academy as passed by the general boby.
- d) To collect and utilize the funds and their disposal to the best interest of the schools /Academy and to do all acts in connections with its aim and object.
- e) To appoint auditors, internal or external, to audit the accounts.
- The Managing Committee may extend special invitation to anybody to attend and to Take parts in any of its meeting such persons shall be over and above the Maximum Number fixed for the society / Committee. Such person, however, shall have not any Right to exercise his vote in the meeting .
- The Vice Chairman shall be responsible for all internal of the Schools/ Academy.

10. Accounts

The accounts of the Society be opened in the Bank recognized by the Society. Accounts of the Society shall be operated upon by the Chairman or Secretary or such persons appointed by the Managing Committee in the absence.

Meeting

- The annual meeting of the Society shall be held once in every Financial year in the Month of April. The Secretary shall decide time, date and venue of the meeting. Meetings can also be called more than one time in year to the need of the Society as and when the Secretary feels it necessary.
- b) Meeting shall be held / called at a notice of one cek time. Urgent meeting can be called at a shorter notice of twenty four hours.
- one third (1/3) members shall form the quorum. An adjourned meeting requires no quorum.
- d) Matters shall be decided by a majority of votes in case of tie, Chairman shall exercise his casting Vote.

LOANS AND ADVANCES:-12.

The Society can avail any type of loan from any Bank and/or Financial Institutions or unsecured Loans from its members and other person with/without interest for the attainment of its Objects. The society can mortgage its movable and properties for the purpose of availment of loans.
